#### AGREEMENT FOR THE INSTALLATION OF STORMWATER BEST MANAGEMENT PRACTICES FOR EDUCATION AND OUTREACH PURPOSES

THIS AGREEMENT is entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2013, between the City of Columbia, Missouri, a constitutional charter city (hereinafter "City") and Stephens College, 1200 East Broadway, Columbia, MO 65215 (hereinafter "Stephens").

WHEREAS, a significant public purpose can be served through education and outreach to raise awareness about stormwater runoff and its management; and

WHEREAS, City's Public Works Stormwater Outreach and Education Program seeks to partner with willing educational institutions, such as Stephens, and other public and private schools to help construct stormwater best management practices (hereinafter "BMPs") and use the BMPs as a focus for education; and

WHEREAS, Stephens is willing to provide locations for stormwater BMPs where Stephens will treat and improve the quality and reduce the quantity of stormwater runoff in areas where the BMPs can be viewed by the general public; and

WHEREAS, Stephens will provide significant material and support for the construction of the BMPs; and

WHEREAS, Stephens will maintain the BMPs which are constructed; and

WHEREAS, City and Stephens will use the BMPs to raise awareness among the college's students and the general public about stormwater runoff and its management.

NOW, THEREFORE, in consideration of the foregoing recitals, which are contractual in nature, and for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, City and Stephens agree as follows:

- 1. Stephens and City agree that the primary purpose of the BMPs is for stormwater outreach and education and will not supplant or replace or be considered a waiver of City, State or Federal requirements under the law. Any incidental benefit of the BMPs in complying with legal stormwater requirements is outside the scope of this Agreement and must be addressed separately under the law.
- 2. Stephens and City agree to work reasonably together to complete education BMPs and may mutually, in writing, terminate the project at any time.

#### 3. STEPHENS RESPONSIBILITIES:

a. Provide the materials, work and labor as set forth in Attachment A, attached hereto and made a part of this agreement hereof.

- b. Provide long-term maintenance of the BMPs.
- c. Stephens shall have ownership, control and responsibility for the BMPs.

#### 4. CITY RESPONSIBILITIES:

a. Provide materials as set forth in Attachment A, attached hereto and made a part of this agreement hereof.

b. Provide consultation on design and planting , assist with the layout of the BMPs and install signage.

c. Total payment by the City under this Agreement described herein shall not exceed Five Thousand Dollars (\$5,000.00).

d. This Agreement shall impose no liability on the City with respect to the maintenance, function or repair of any storm water facilities and improvements on the Stevens property.

- 5. <u>Hold harmless agreement.</u> To the fullest extent not prohibited by law and without waiver or limitation for either party's rights or defenses with regard to each party's applicable sovereign, governmental or official immunities and protections as provided by federal and state constitution or law, each party shall indemnify and hold harmless the other, its directors, officers, agents and employees from and against all claims, damages, losses, liability and expenses in connection with these responsibilities, improvements and services arising from this Agreement.
- 6. <u>Sole benefit of parties.</u> This Agreement is for the sole benefit of City and Stephens. Nothing in this Agreement is intended to confer any rights or remedies on any third party.
- 7. <u>Assignment.</u> Neither City or Stephens shall assign or transfer its interest in this Agreement without the express written consent of the other.
- 8. <u>Law; submission to governing jurisdiction.</u> This Agreement shall be governed by, interpreted and enforced in accordance with the laws of the State of Missouri or the laws of the United States, as applicable. The venue for all litigation arising out of, or relating to this Agreement, shall be Boone County, Missouri or the United States Western District of Missouri. The Parties hereto irrevocably agree to submit to the exclusive jurisdiction of such courts in the State of Missouri and waive any defense of forum non conveniens.

- 9. <u>No attorney's fees</u>. It is agreed that in any action to enforce the terms of this Agreement, each Party shall be responsible for its own attorney's fees and costs.
- 10. <u>Entire agreement.</u> This Agreement represents the entire and integrated Agreement between City and Stephens. All previous or contemporaneous agreements, representations, promises and conditions relating to this Agreement herein are superseded.

**Re:** Agreement to Partner with Stephens College to Install Water Quality Practices for Education

#### EXECUTIVE SUMMARY:

Staff has prepared for Council consideration a resolution authorizing the City Manager to execute an agreement with Stephens College to assist with construction of a stormwater best management practice (BMP) on their property, for the purpose of of educating students as well as the general public about stormwater management.

#### **DISCUSSION:**

Educational institutions are uniquely suited to reach a broad, inexhaustible audience who are ready and willing to learn. Stormwater BMPs installed at these institutions provide a focus for discussion and learning about stormwater, and proper treatment and management. Public Works Stormwater Outreach and Education program would like to partner with willing educational institutions, such as public and private schools, to help construct BMPs to be used as a focus for education.

Initially, Public Works would like to partner with Stephen's College facilities and management personnel to implement BMPs near the Stephens College stables. With the assistance of City staff, Stephens College is designing a bioswale and rain garden near the corner of Ann and Walnut streets, in the Benton-Stephens neighborhood (see attached diagrams). This agreement with Stephens College is intended to serve as a template to be used with other educational institutions wanting to partner with the City on BMP projects.

#### FISCAL IMPACT:

The total estimated project cost is \$13,375, with Stephens College responsible for \$10,000 and the City's share of \$3,375 (see attached breakdown).


