AMENDMENT NO. 3 to AGREEMENT For PROFESSIONAL ENGINEERING SERVICES Between THE CITY OF COLUMBIA, MISSOURI

THIS CONTRACT AMENDMENT made as of _____ day of ____, 20____, by and between the City of Columbia, Missouri, hereinafter called the CITY, and Cook, Flatt & Strobel, Engineers, P.A. of Kansas City, Missouri, hereinafter called the ENGINEER.

WITNESSETH, that whereas it is the mutual desire of the parties hereto to amend the AGREEMENT for PROFESSIONAL ENGINEERING SERVICES for the Route 740/Stadium Boulevard Project entered into on the 1st day of October, 2007, and Amendment No. 1 entered into on the 9th day of February 2011, and Amendment No. 2 entered into on the 6th day of November, 2012; hereinafter called Existing Agreement.

This Amendment is for changes or additions to the Scope of Improvements for the Route 740 (Stadium Boulevard) corridor as described in the Existing Agreement This Amendment directs the Engineer to provide PROFESSIONAL ENGINEERING SERVICES based upon the revised design configurations for the Route 740 (Stadium Boulevard) corridor as discussed and agreed upon by the City of Columbia and the Missouri Department of Transportation. The amended Professional Engineering Services consists of the following improvements:

- 1. Revisions to plans to eliminate easements from Columbia Mall.
- 2. Revisions to plans to eliminate improvements to Fairview Road.
- 3. Additional design around Utilities, as needed, to expedite construction adjustments.

Therefore, it is hereby agreed that the Existing Agreement be amended as follows:

SECTION 5 - PERIOD OF SERVICE

5.3 Services shall be completed within three hundred sixty-five (365) calendar days from the execution of this Amendment to the Existing Contract. CITY shall have the right to establish performance times for individual phases or elements of the

PROJECT by delivering a written schedule setting out the performance times to the ENGINEER.

SECTION 6 - PAYMENTS TO ENGINEER

- 6.1.1.1 For time spent by personnel, payment at the hourly rates indicated in the "2013 Rate Schedule" (attached). Such rates include overhead and profit. The schedule is effective to January 2014, and may be revised thereafter.
- 6.1.2 Total payment for the Scope of Services shall be amended from \$1,849,909.39 to \$1,957,904.39.

Except as expressly provided in this Amendment, the terms of the Existing Agreement shall remain in full force. The Parties herby adopt, ratify, and confirm the Existing Agreement as it is amended by this Amendment. All previous or contemporaneous agreements, representations, promises and conditions relating to ENGINEER's services described herein are superseded. This Amendment shall be binding on, and inure to the benefit of, the Parties hereto and their successors and assigns. This Amendment may be executed in any number of counterparts and each shall be considered an original. Together the counterparts shall constitute one agreement. Facsimile signatures of this Amendment shall be deemed original signatures for all purposes.

EXECUTIVE SUMMARY:

Staff has prepared for Council consideration a resolution authorizing the City Manager to execute Amendment No. 3 to the October 1, 2007 professional services agreement with Cook, Flatt and Strobel Engineers, P.A., for the Stadium Boulevard Corridor projects. This amendment modifies the scope of services to include adjustments to the construction plans as engineering input is needed throughout construction.

DISCUSSION:

The City of Columbia retained Cook, Flatt and Strobel Engineers, P.A., to provide design engineering services for the Stadium Boulevard Corridor projects as outlined in a Professional Engineering Services agreement dated October 1, 2007. The project did not move forward until all agreements with the Missouri Department of Transportation (MoDOT) and the Transportation Development Districts (TDDs) were finalized in October, 2009. A concept drawing was approved by Council at the July 19, 2010 public hearing.

MoDOT let the Stadium Corridor projects in January 2013, and has reimbursed the City for half of the design services on portions of the project on their right-of-way. Through MoDOT management of the letting and construction, several plan revisions were required. These include \$10,035 to eliminate work along Fairview Road to bring the construction costs within budget, and \$47,960 for revisions to eliminate right-of-way easements that were not desired by property owners at the Columbia Mall. In addition, \$50,000 is proposed for the consultant to provide design for any other construction issues that occur on this complex project. The \$50,000 will not be billed if the consultant services are not needed.

FISCAL IMPACT:

The total cost of Amendment No. 3 is \$107,995.00, and will be paid from the Stadium TDD capital improvement project account. MoDOT agrees to reimburse the City for \$28,997.50, half of the identified aforementioned fees (does not include the \$50,000 for unexpected construction issues), and will continue to pay for half of the design services on MoDOT right-of-way.
