AN ORDINANCE

vacating drainage easements and a sanitary sewer easement within Magnolia Falls Subdivision Plat 2 located southeast of the intersection of Old Mill Creek Road and State Route KK; directing the City Clerk to have a copy of this ordinance recorded; and fixing the time when this ordinance shall become effective.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council finds and determines that certain drainage easements and a sanitary sewer easement within Magnolia Falls Subdivision Plat 2 located southeast of the intersection of Old Mill Creek Road and State Route KK, more particularly described as follows:

EXECUTIVE SUMMARY:

A request by A Civil Group, on behalf of Beacon Street Properties, LLC, (owner), to vacate and dedicate several drainage easements and vacate an existing sewer easement within the boundaries of Plat 2 of the Magnolia Falls subdivision. The site is located at the southeast corner of Old Mill Creek Road and east of State Route KK. (Case #13-126)

DISCUSSION:

The applicant seeks to vacate five and dedicate two new drainage easements within the boundaries of Plat 2 of the Magnolia Falls subdivision. This request also proposes to vacate the sewer easement between lots 27 and 28 within subdivision. The requested drainage easement vacations are the result of a revised lot layout. The sanitary sewer easement to be vacated was never used during the construction of the homes on lots 27 and 28.

The two new drainage easements to be dedicated will appear on a revised final plat scheduled for Council consideration during its October 7 meeting. Final approval of the proposed easement vacations (drainage and sewer) would occur at the same meeting. This request has been reviewed by applicable internal and external departments and agencies and is supported.
