A RESOLUTION

declaring the necessity for construction of sanitary sewers in Sewer District No. 170 (Poplar Hill Drive); stating the nature of and the estimate of the cost thereof; providing for payment for the improvement; providing for compliance with the prevailing wage law; and fixing the time for a public hearing thereon.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council deems the construction of sanitary sewers, wye branches, manholes and other necessary appurtenances in Sewer District No. 170 (Poplar Hill Drive) necessary to the welfare and improvement of the City.

SECTION 2. The nature and scope of the improvement shall consist of furnishing all labor, materials, transportation, insurance and all other items, accessories and incidentals thereto necessary for the complete construction of the improvements.

SECTION 3. The estimated cost of this improvement is \$302,240.00.

SECTION 4. Payment for this improvement shall be made by special tax bills evidencing special assessments levied and assessed against the lots, tracts or parcels of ground specially benefited in Sewer District No. 170 of the City, in proportion to the area of the whole district exclusive of public highways, in the manner specified by the laws of the State of Missouri and the Charter and Ordinances of the City of Columbia, in a unit rate not to exceed \$0.5225 per square foot; and the balance from Sanitary Sewer Utility Funds and such other funds as may be lawfully appropriated or lawfully used for such purpose, the boundaries of the sewer district being described as follows:

SECTION 5. Any work done in connection with the construction of the improvement specified above shall be in compliance with the provisions of the prevailing wage laws of the Department of Labor and the State of Missouri, such prevailing wage rates having been established by the Industrial Commission of Missouri.

SECTION 6. A public hearing in respect to this improvement will be held in the Council Chamber of the City Hall Building, 701 E. Broadway, Columbia, Missouri, at 7:00 p.m. on November 18, 2013. The City Clerk shall cause notice of this hearing to be published in a newspaper published in the City.

EXECUTIVE SUMMARY:

Staff has prepared for Council consideration legislation setting a public hearing for November 18, 2013 concerning construction of sanitary sewers to serve the properties located within Sanitary Sewer District 170, along Poplar Hill Drive and South Bethel Church Road (see attached diagrams). The resolution estimate for this project is \$302,240, with a maximum tax bill rate of \$0.5225 per square foot of property.

DISCUSSION:

Sanitary Sewer District 170 was formed by Ordinance 21772 at the August 19, 2013 City council meeting. The area of the proposed sewer district was voluntarily annexed in 2008, primarily to facilitate this sewer district project. The properties within the proposed sewer district are presently served by on-site sewer systems. The sewer district boundary encompasses 10 parcels of land.

The resolution estimate for this project is \$302,240. The maximum tax bill rate will be \$0.5225 with the tax bill amounts to the individual properties ranging from \$2,880 to \$93,325. Six properties qualify for the \$5,000 tax bill cap, two properties estimated below the \$5,000 cap, and two properties qualify for the \$10,000 cap for R-2 zoning. Approximately \$241,000 in tax bills will be deferred as provided in Chapter 22-97.1 of the City Code of Ordinances.

FISCAL IMPACT:

The estimated cost is \$302,240, with funding from the Sewer Utility, tax bills and deferred tax bills levied against properties in the sewer district. The completed project will add approximately \$2,100 in annual maintenance costs for the Sewer Utility.




