AN ORDINANCE

authorizing the City Manager to apply to the United States Department of Transportation Federal Aviation Administration and the Missouri Department of Transportation for airport capital assistance grants; authorizing the Public Works Director to furnish information; authorizing the City Manager and City Counselor to execute certifications and assurances; authorizing the City Manager to execute grant agreements; authorizing electronic filings; and fixing the time when this ordinance shall become effective.

WHEREAS, the City of Columbia operates an airport facility; and

WHEREAS, if the City receives a grant from the U.S. Department of Transportation Federal Aviation Administration and the Missouri Department of Transportation, the contract for financial assistance will impose certain obligations upon the City, including the obligation to provide the local share of project costs.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Manager is authorized to apply to the U.S. Department of Transportation Federal Aviation Administration, on behalf of the City of Columbia, for capital assistance grants to aid in financing the City's airport facility.

SECTION 2. The City Manager is authorized to apply to the Missouri Department of Transportation, on behalf of the City of Columbia, for capital assistance grants to aid in financing the City's airport facility.

SECTION 3. The Public Works Director or the Director's appointed designee, acting as the City Manager's representative, is authorized to furnish any additional information required by the Federal Aviation Administration and Missouri Department of Transportation in conjunction with the grant application and management.

SECTION 4. The City Manager and the City Counselor are authorized to execute and file with the Federal Aviation Administration and the Missouri Department of

Transportation the required certifications and assurances and any other documents required by the Federal Aviation Administration and the Missouri Department of Transportation to submit such applications and enter into any grant agreements associated with such applications.

SECTION 5. The City Manager is authorized to execute a grant agreement with the U.S. Department of Transportation Federal Aviation Administration and the Missouri Department of Transportation, on behalf of the City of Columbia, for aid in financing airport capital improvements. The City Manager is further authorized to execute supplemental grant agreements for additional grants that may become available during the current federal and state fiscal year.

SECTION 6. The Public Works Director or the Director's appointed designee is authorized to review and submit electronically to the Federal Aviation Administration and the Missouri Department of Transportation grant applications, quarterly reports, and any other required information.

SECTION 7. This ordinance shall be in full force and effect from and after its passage.

Obtaining Columbia Regional Airport Grant Application and Execution Authority for 2014 Federal Aviation Administration and the Missouri Department of Transportation Capital Assistance

EXECUTIVE SUMMARY:

Staff has prepared for Council consideration legislation authorizing the City Manager to make application and execute all necessary documents for Columbia Regional Airport capital assistance grants throughout 2014 from the Federal Aviation Administration (FAA) and the Missouri Department of Transportation (MoDOT).

DISCUSSION:

This legislation is an annual renewal of the City Manager's authorization to make application for FAA and MoDOT grants, submit required certifications and assurances, execute grant offers and supplemental grant amendments, and submit any other required information on behalf of the City of Columbia and Columbia Regional Airport. This legislation also authorizes the Public Works Director, or his appointed designee, to furnish additional grant related information required by the FAA and MoDOT, and to review and submit electronically to the FAA and MoDOT grant applications, quarterly reports and other required information, on behalf of the City of Columbia and Columbia Regional Airport.
