

 - Gather Customer Experience Data
 - Gather Staff Experience Data
 - Compile Data in Report to Council
 - Utilize Data to Design Automated Trash Collection System if Directed by Council

- How Will We Accomplish our Goals?
 - Identify Participants
 - Council Selected
 - Volunteer
 - Ideally 600 Participants
 - 100 From Each Ward
 - Various Age Groups
 - Various Locations (East Campus)

PILOT PROJECT DESCRIPTION

- Why Not 32 Gallon Roll Carts?
 - Industry Moving Away
 - Difficult to Service with Automated Trucks
 - Carts This Size Slip From Arm
 - Customers Tend to Over Pack
 - Makes Emptying of Cart Difficult
 - Unstable in Windy Conditions
 - Being Replaced by Other Cities and Industry with 48 Gallon Cart

PILOT PROJECT Fees and revenue

- Pilot Fees Will Be Realistic to Proposed Fees
- Additional Carts Available for Monthly Fee
 - \$10.00
- Bag(s) Outside of Cart
 - \$1.00 per bag
 - Will sell stickers to place on bags
- Bulky Items
 - \$5.00 per item
 - Defined as items such as chairs, sofa, etc.

PILOT PROJECT SAVINGS POTENTIAL

- Current Bag Voucher Program
 - Eight (8) Residential Routes
 - Two Employees per Route
 - Average House Count per Route per Day is 861
- Proposed Automated Collection Program
 - Eight Residential Routes
 - One (1) Employee per Route
 - Realistic House County per Route per Day is 1,000 to 1,100.
 - Two Bulky Item Trucks with Two Employees per truck

Potential Ordinance Changes

- Establish Times
 - Cart Set Out Time
 - Cart Returned to House
- Location of Carts for Collection to Occur
 - Carts May Not be Placed Closer than 6' to Mailboxes
 - Carts May Not be Placed Closer than 3' to Other Objects
- Addressing Over Filled Containers and Bulky Items
- Collection of Bags Outside of the Cart(s)
- Carts Used by Others to Avoid Fees
- Lost, Damaged, or Stolen Carts

Potential Ordinance changes

- Cleaning and Maintenance of Carts
- Change to Ordinance which Provides Trash Bag Vouchers
- Address Multiplex Units to Define Between Cart Use and Dumpster Use
