#### **Executive Summary**

Setting a public hearing for June 2, 2014 concerning the construction of sanitary sewers, water line replacement, and electric line burial, to serve properties located within PCCE #8 - Thilly, Lathrop, Westmount Sewer Improvement project, which also includes homes along Garth Avenue and Stewart Road. The proposed sewer improvement project consists of seventy-four (74) homes, and is served by multiple private common collector (PCC) sewers. The water line replacement will affect twenty-one (21) homes, and the electric line burial will affect forty-five (45) homes.

#### Discussion

The properties currently connected to the PCC sewers in this area have been experiencing problems with stoppages, backups and overflows due to the deteriorated condition of the private common collector sewer. City sewer maintenance crews have responded to several sanitary sewer overflows; and the Health Department has been contacted by local residents regarding potential health and safety risks associated with the overflows.

Staff was asked to speak at a neighborhood meeting held on July 16, 2008, to introduce the residents to the Private Common Collector Elimination (PCCE) process. A large percentage of the area signed petitions, and the Thilly, Lathrop, Westmount PCCE was formed August 11, 2008. Staff worked on preliminary designs and held the area's first Interested Parties (IP) meetings on February 3rd, 17th, and the 24th of 2010. At the meetings, homeowners voiced their support for the proposed PCCE project and asked staff to also evaluate water line replacement and the burying of existing overhead electric lines. In response to the citizen input, staff from both Water & Light and Public Works, held a joint meeting to discuss the sewer, water and electric improvement project. The most recent IP meetings were held on December 17th and 18th of 2013. Twenty (20) people attended the meetings and spoke in favor of the sewer, water and electric projects.

To date, staff has been successful in contacting forty-five (45) of the seventy-four (74) property owners impacted by the proposed project, all of which have indicated support of the project. Staff has met on-site with most of the 45 property owners to discuss the alignment and impacts to the properties. Staff has made multiple phone calls, sent letters and emails, but have not been able to contact twenty- nine (29) property owners. Staff will continue to attempt to contact the remaining homeowners and work with all the homeowners on alignment alternatives and construction questions.

The PCC sewer lines are the catalyst to this project. The water and electric improvement portion of this project arose during preliminary sewer design discussions with the property owners. The sewer, water and electric work is being closely coordinated to minimize utility conflicts and property impacts. The existing PCC sewer was constructed with some sewer lines leaving the front of homes, and some leaving the rear of homes. In order to serve all homes, while minimizing the depth of which the new sewer has to be installed (following natural ground terrain), the sewer could not be routed in a normal path from block to block as the electric and water lines will. Preliminary alignment of all three utilities are shown on the attached diagram.

Staff anticipates phasing the construction of this project as easements are acquired to better facilitate construction in smaller areas.

The three separate infrastructure needs are described below.

#### Water:

The water lines (see attached location diagram) being considered for replacement are constructed of aging 4-inch diameter wrought iron and cast iron. The mains are located in the back yards which cause difficulty in maintaining the system, and have proven to be unreliable at times. The new water line is to be constructed out of modern 6-inch pvc in front of the homes, within the right-of-way. The new water mains will allow for a more maintainable water distribution system while improving the dependability and the fire flow capabilities of the area. The water main construction will precede the sewer work in order to vacate the existing four inch mains within the limits of the projected sewer construction. Each customer service line will be tied over to the new water main at no charge to the homeowner; however, we are suggesting that each property owner consult with a plumber about replacing their existing water service line between the water meter and their home, in order to have an entirely new water service connection.

#### Sewer:

This work will consist of constructing approximately 7,247 linear feet of gravity sewer, and will include new private service connections and replacement of service laterals required to reconnect the existing structures to the new sewer main. Staff intends to phase the construction of this project into smaller areas based on easement acquisition..

#### Electric:

The homeowners have voiced support for the Water and Light (W&L) department to bury the high voltage lines and install new pad-mounted transformers in the rear yards. W&L is willing to begin the

electrical work as soon as all necessary easements have been donated. W&L will maintain the wood poles in the back yards for as long as necessary to support the overhead service drops to the houses. Homeowners will be encouraged to put their service line underground. For homeowners that desire to bury their service line, W&L will furnish a new underground style meter base to be mounted on the house by the homeowner's electrician, and will provide the new underground conductor from the utility transformer to the meter. Before this can be done, the homeowner will need to provide the necessary conduit path for the electric, telephone, and cable services, across their back yard from the utility easement on the rear lot line, to the service entrance location on the house. After the service has been transitioned to underground, W&L will remove the old overhead electric service drop at no cost to the homeowner. Eventually, W&L will be able to remove the wood poles once there are no remaining overhead service drops to be supported.

Public Works and Water & Light will continue with coordination efforts throughout this project to ensure all improvements are constructed with the least amount of land disturbance possible, and to minimize impact to the property owners.

## Fiscal Impact

Short-Term Impact: The resolution estimate for the sewer project is \$2,200,000 and funding shall come from Annual Private Common Collector funds provided in the April 2008 and November 2013 ballots. To date, \$628,421.69 has been appropriated to this project with the remaining balance needed from Private Common Collector funds and Sanitary Sewer Utility CIP.

The engineer's estimate for the water distribution system improvement is \$546,000. Financing for this project is proposed to come from a revenue bond package approved by voters in the 2008 ballot issue. Funding for this project has been previously appropriated under CIP project number WT0235.

The W&L department estimates \$300,000 for the electric portion, and will be paid from the budget for underground lines, project number EL0027.

Long-Term Impact: It is anticipated that this project will have minimal impact on the sewer utility's annual operating costs.



#### **A RESOLUTION**

declaring the necessity for construction of the Thilly, Lathrop, Westmount PCCE #8 sanitary sewer, water line replacement and electric line burial improvement project; stating the nature of and the estimate of the cost of the improvement; providing for payment for the improvement; providing for compliance with the prevailing wage law; and setting a public hearing.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council deems the construction of sanitary sewers, wye branches, manholes and other necessary appurtenances, replacement of a 4-inch wrought iron and cast iron main with a 6-inch PVC water main, and burial of high voltage electric lines and the installation of pad-mounted transformers in rear yards, all in accordance with City of Columbia Street and Storm Sewer Specifications and Standards, as part of the Thilly, Lathrop, Westmount PCCE #8 sanitary sewer, water line replacement and electric line burial improvement project, necessary to the welfare and improvement of the City.

SECTION 2. The nature and scope of the improvement shall consist of furnishing all labor, materials, transportation, insurance and all other items, accessories and incidentals thereto necessary for the complete construction of the improvements.

SECTION 3. The estimated cost of the sanitary sewer improvement is \$2,200,000.00; the estimated cost of the water distribution system improvement is \$546,000.00; and the estimated cost of the electric line burial improvement is \$300,000.00.

SECTION 4. Payment for this improvement shall be made from sewer system revenue bonds, from Water and Electric Funds using funds appropriated in Capital Improvement Project Nos. WT0235 and EL0027, and such other funds as may be lawfully appropriated.

SECTION 5. Any work done in connection with the construction of the improvement specified above shall be in compliance with the provisions of the prevailing wage laws of the State of Missouri.

SECTION 6. A public hearing in respect to this improvement will be held in the Council Chamber of the City Hall Building, 701 E. Broadway, Columbia, Missouri, at 7:00 p.m. on June 2, 2014. The City Clerk shall cause notice of this hearing to be published in a newspaper published in the City.
