### **Executive Summary**

An ordinance amending the FY14 Budget for the Department of Public Health and Human Services to amend the Permanent Full-Time Position Count to add 0.1 FTE Health Educator.

#### Discussion

The Department of Public Health and Human Services (PHHS) received an increase in the Teen Outreach Program (TOP) contract from the Missouri Department of Health and Senior Services during FY 14. The additional funds allow PHHS to expand the program to include outreach to students at three additional schools. An additional four hours per week added to an existing permanent part-time Health Educator position is needed to carry out the program. The Missouri Department of Health and Senior Services has indicated this funding will be sustainable in future years.
