

Staff has prepared for Council consideration a resolution granting a waiver of the open container ordinance and approval for the South East Craft Beer Festival.

## Discussion

Jacob Halls is requesting a waiver of the open container ordinance for Fay Street, from Wilkes Blvd. to Smith St., and Hinkson, between College Ave and Fay St., on August 23rd, 2014, from 1:00 p.m. until 7:00 p.m., to hold the South East Craft Beer Festival.

The City Event Committee has reviewed and approved street closures of the proposed area with conditions to ensure safety for the event-goers and the public. Mr. Halls meets all requirements set forth in Chapter 24 of the City Code as it relates to special event permits.



**A RESOLUTION**

granting a temporary waiver from the requirements of Section 16-185 of the City Code to allow possession and consumption of alcoholic beverages for the South East Craft Beer Festival.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby grants a temporary waiver from the requirements of Section 16-185 of the City Code so that the possession of an open container of alcohol and consumption of an alcoholic beverage shall be allowed on August 23, 2014 from 1:00 p.m. until 7:00 p.m. for the area along a portion of Fay Street between Wilkes Boulevard and Smith Street, and the area along a portion of Hinkson Avenue between College Avenue and Fay Street, during the South East Craft Beer Festival.




