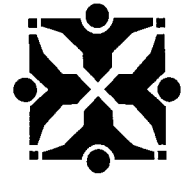

Executive Summary

A resolution setting a public hearing for Monday July 21, 2014, for the construction of sidewalk improvements along Manor Drive, from Rollins Road to West Broadway, as shown on the attached location map. An Interested Parties (IP) meeting was held in May 2008, and follow-up meetings were held April 23, 2013 and August 13, 2013.

Discussion

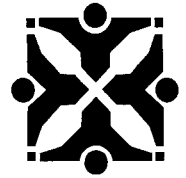
The Manor Drive Sidewalk project, from Rollins Road to West Broadway, is part of the Non Motorized Transportation (GetAbout) program. Preliminary design of this project was completed under original GetAbout Phase I funding. The project includes construction of a 6-ft wide sidewalk at the back of the curb on the east side of Manor Drive, from Rollins Road to Manor Court, then crossing to the west side of Manor Drive and continuing toward West Broadway; finally tying into existing sidewalk near Broadway. The concept includes approximately 2,550 lineal ft of sidewalk and reconstruction of 26 driveways to meet ADA requirements.

Based on public comments, the street width will be narrowed by 6 ft in three locations, ranging from approximately 100 ft to 200 ft in length to serve as traffic calming, to minimize the need for retaining walls, to avoid some large mature trees, and improve driveway accessibility. Based on the current plans, staff anticipates removal of six (6) trees along the corridor. Current preliminary typical section and plan view diagrams are attached. Staff anticipates construction to be completed in 2015.

An IP meeting was held for this project in May 2008 and attendees were generally supportive. The May meeting was held in conjunction with other GetAbout projects in the area, and some of the attached public comments may not be directed at this specific project. Because of the amount of time that had passed since the initial IP meeting, a second meeting was held April 23, 2013. Ten (10) people signed in at the meeting, and most were supportive but concerned about the width of the sidewalk, potential tree removal, and stormwater drainage impacts. Nine (9) official comments were received. A follow-up IP meeting was held August 13, 2013 to gather feedback on the proposed plan revisions made in response to comments from the April meeting. Comments from all of the IP meetings are attached.

“Speed is a big problem on Manor Drive. People drive 50 and 60 mph on this street daily. At the northeast corner of 412 Manor drives lot is a very low spot that water has to flood the curb to drain through the yard. A tub or storm drain needs to be installed.”

“My biggest concern is losing my trees. I would prefer no retaining wall- regrade dirt slope. A 42” width is ok as long as a 6ft width is within 200 ft. Could 710 have a 42” sidewalk using the driveway as a 6ft bypass ara.”

Mr. Campbell brought and submitted a list of concerns that was written prior to the meeting. His concerns are as follows:

“Reasons Not to Proceed with the Manor Sidewalk Project

Trees - Taking a ten foot easement to put in a five foot sidewalk will kill many of the mature trees that now line Manor Dr. The shade provided by many of these trees helps reduce electricity cooling cost in the summer. The trees also add an aesthetic quality to the neighborhood that will be lost. Even if the city replaces the trees, it will be decades before the shade and beauty of the neighborhood are restored.

Stated Purpose of the sidewalk – is to provide a safe pedestrian route to Russell School. This is not the case. There is an existing sidewalk that runs parallel to the proposed Manor Dr. sidewalk one block over on Russell blvd that end at a guarded school crosswalk. If the concern was to provide a sidewalk from Clinkscales Rd. to the school, it would be safe and more cost effective to add a sidewalk from the Southeast corner of Manor along West Broadway to Russell Blvd.

Sidewalk Width – Why is the sidewalk five feet in width when the existing connecting sidewalks are only three foot wide? This does not make sense. Why is a two foot green space needed between the road and the sidewalk? The city recently added a sidewalk on Hunt Ave that is only three foot wide and has no green space between the road and the sidewalk. Why is there a difference between sidewalks? Could it be due to spending city money vs. free Federal money?

Homeowner Responsibility – the home owner responsibility and liability increase with the addition of a sidewalk. The city requires the homeowner to maintain the sidewalk accessibility. Snow removal and removing obstruction is the responsibility of the homeowner under penalty of law. This will create a hardship to the elderly and other whom cannot maintain their portion of the sidewalk. Even when the homeowner maintains their portion of the sidewalk, one’s liability is not diminished. If the snow is removed and someone slips, the homeowner can be sued, because a lawyer will argue that the owner did a poor job of snow removal.

Loss of homeowner driveway parking space – by having the sidewalk take up so much of one’s front yard, the available parking space will be significantly reduced. Currently, cars can be parked one in front of the other, but with the addition of the sidewalk this will not be possible because the second car located closer to the street will be blocking the sidewalk. This will force more people to park on the street and will effectively make Manor Dr. a one lane rd in many locations.

A RESOLUTION

declaring the necessity for construction of sidewalk improvements along Manor Drive, from Rollins Road to West Broadway; stating the nature of and the estimate of the cost of the improvement; providing for payment for the improvement; providing for compliance with the prevailing wage law; and setting a public hearing.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF COLUMBIA, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council deems the construction of a six-foot wide sidewalks along the east side of Manor Drive between Rollins Road and Manor Court, and on the west side of Manor Drive between Manor Court and West Broadway, and the reconstruction of 26 driveways to meet ADA requirements and other miscellaneous work, all in accordance with City of Columbia Street and Storm Sewer Specifications and Standards, more specifically described as the Manor Drive Sidewalk Project, necessary to the welfare and improvement of the City.

SECTION 2. The nature and scope of the improvement shall consist of furnishing all labor, materials, transportation, insurance and all other items, accessories and incidentals thereto necessary for the complete construction of the improvements.

SECTION 3. The estimated cost of this improvement is \$438,600.00.

SECTION 4. Payment for this improvement shall be made from Non-Motorized Transportation Funds and such other funds as may be lawfully appropriated.

SECTION 5. Any work done in connection with the construction of the improvement specified above shall be in compliance with the provisions of the prevailing wage laws of the State of Missouri. The City shall also cause to be inserted into the contract a stipulation that all laborers and mechanics employed by the contractor or subcontractors in the performance of work under the contract shall be paid wages at rates not less than those prevailing on similar construction in the locality as determined by the Secretary of Labor in accordance with the Davis-Bacon Act.

SECTION 6. A public hearing in respect to this improvement will be held in the Council Chamber of the City Hall Building, 701 E. Broadway, Columbia, Missouri, at 7:00 p.m. on July 21, 2014. The City Clerk shall cause notice of this hearing to be published in a newspaper published in the City.
