### **Executive Summary**

William S. McKenzie, John T. Clark and Jack H. Morgan were all appointed by City Council as associate municipal court judges on August 16, 2010 to four year terms, pursuant to Section 115 of the Home Rule Charter and Section 15-50 of the City of Columbia Code of Ordinances. Their terms expire August 16, 2014. All three would be reappointed by City Council, Clark and Morgan for four year terms, and McKenzie for a term set to expire May 13, 2016.

#### **Discussion**

Section 15-50 of the Code of Ordinances of the City of Columbia requires at least three associate municipal judges to hear and decide cases in the City of Columbia municipal division of the circuit court. City Council makes those appointments. Currently William S. McKenzie, John T. Clark and Jack H. Morgan serve as associate municipal judges under those provisions. City Council appointed them on August 16, 2010 (R 164-10). The four year terms of all three expire on August 16, 2014.

McKenzie, Clark and Morgan are all willing and interested in reappointment as City of Columbia associate municipal judges.

Clark and Morgan would be reappointed to four year terms. McKenzie would be reappointed to a term set to expire on May 13, 2016, to comply with Missouri Revised Statutes, Chapter 479, Section 479.020(7) and Section 15-46 of the Columbia Code of Ordinances (no person shall serve as municipal judge after that person has reached that person's seventy-fifth birthday).
